Sub: Rescheduling of the meeting of Board of Directors - Regulation 29 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This has reference to the subject and the letter cited above.

The Board Meeting, which was scheduled to be held on Friday, July 17, 2020 has been rescheduled to Thursday, July 23, 2020, due to lockdown announced by the Government of Karnataka vide its Order dated July 13, 2020 on account of COVID-19 pandemic.

At the said meeting, inter-alia, the following proposals will be placed for consideration/ review, for obtaining approval from the shareholders at the ensuing Annual General meeting of the Company;

(1) Raising funds by way of issue of equity shares through qualified institutions placement and/or preferential issue to promoters or rights issue and/ or any other permissible securities, subject to such approvals as may be required.

(2) Borrowing/ raising funds by issue of non-convertible debentures and/or non-convertible subordinated debt Tier- II debentures, in terms of Section 42 of the Companies Act, 2013 read with relevant rules and the Listing Regulations, as amended.

At the said meeting, the proposal for re-validation of the earlier authorisations given by the Board for issuing Non-Convertible Debentures (NCDs), as required by NHB Directions, will also be placed.


