This is to inform that the statutory auditors of the Company M/s. Varma & Varma, Chartered Accountants, (Firm Registration No. 004532S), have given the letter of resignation dated 10/08/2021, consequent to applicability of RBI guidelines dated 27/04/2021.

The resignation would take effect from the date on which the new Auditors are appointed at the ensuing Annual General Meeting of the Company (Scheduled on 08/09/2021). A copy of the said resignation letter and Annexure-A, as required under the SEBI Circular No.CIR/CFD/CMD1/114/2019 dated 18/10/2019, are enclosed.

The reason for resignation:

The Auditors have submitted the letter of resignation due to operation of the guidelines issued by the Reserve Bank of India (Ref. No. DoS.CO.ARG/SEC.01/08.91.001/2021-22 dated 27/04/2021. As per the said guidelines they are not eligible to continue as Auditors of the Company as they have already completed four years as Statutory Auditors of the Company.

The Audit Committee at its meeting held on 11/08/2021 noted the contents of the letter of resignation of M/s Varma & Varma, Statutory Auditors of the Company and of the view that there are no concerns for deliberations by the Committee since the resignation is on account of applicability of regulatory guidelines.



We shall arrange to file Form ADT-3 with the Registrar of Companies on receipt of confirmation from your end.


