- d) The sealed quotations should be submitted at our Gachibowli Hyderabad branch at above mentioned address on or before 15/09/2022 by 03.00 PM.
- e) If last day of submission of quotations is declared as holiday under NI Act/Government, the next working day will be deemed to be the last day for submission of the quotation.
- f) The quotation which is/are deposited after the said date and time shall not be considered. No offer will be accepted by E-mail.
- g) **The quotations will be opened** in the presence of the bidder's representative on the due date **15/09/2022** @ **04.00 PM** at the above branch address. Bidder's representative may be present in the venue well in time along with an authorization letter, and should sign in Register of Attendance. The Company will scrutinize the quotations received to determine whether they are complete in all respects as per the specifications mentioned above.
- h) If any of the bidders or all bidders who submitted the quotation are not present during the specified date and time of opening, it will be deemed that such bidder is not interested to participate in the opening of the quotations and the Company at its discretion will proceed further with opening of the quotations in their absence.
- i) The Offer submitted and the prices quoted therein shall be valid for 2 months from the last date for submission of the quotation.

- j) No offer can be modified or withdrawn by a bidder after submission of quotation.
- k) The Company reserves its right to reject any or all the offers without assigning any reason thereof whatsoever.
- I) The Company will not be obliged to meet and have discussions with any bidder and / or to entertain any representations in this regard.

# 2. Pricing & Payments

- 2.1. The Price offered to the Company must be in Indian Rupees, and Inclusive of GST. The Contractor has to quote the applicable taxes separately.
- 2.2. The item value along with GST should be claimed in the invoice, location wise and GST will be paid in actual at our end. However please note that taxes will be paid to the maximum of taxes indicated in the Bill of Material.
- 2.3. No escalation in price quoted is permitted for any reason whatsoever. Prices quoted must be firm till the completion of the contract.
- 2.4. From the date of placing the order till the completion of the work, if any changes are brought by the Government, resulting in reduction of the cost of the systems, the benefit arising out of such reduction shall be passed on to the Company.

# 3. Payment Terms

3.1. Payment terms will be 100% on receipt of confirmation from branch about satisfactory completion of the work.
